The Site

Truro offers strong rail links to London, Plymouth, and Penzance, plus local connections like the Falmouth branch line. The area is also well-served by buses and two Park & Ride sites. While the immediate area is more commercial than residential, nearby neighbourhoods offer quieter living with easy access to transport. It's a convenient base for commuters, though safety stats are typical of a central urban location.

Planning

The site currently has a live outline planning application with a determination date set for 11 June. Additionally, there is an active Deed of Variation application seeking to remove the land's designation for railway improvement works, as this requirement has been confirmed as no longer necessary. We have been advised that both applications are expected to be approved.
